

Regular Graded Feeder Cattle Sale

TERMS AND CONDITIONS OF SALE

- 1. Terms of sale are CASH. Settle with treasurer in office immediately after sale.
- 2. All cattle belong to producer until sold; then they immediately become the property of the buyer. Cattle cannot be moved from the barn until the sale is over. Hay and water will be available to cattle prior to sale and for 24 hours after sale without additional expense. A charge of \$1 per head per day will be added for all cattle not moved from barn after first 24 hours following sale.
- 3. Calves must be settled for before being loaded. Personnel will be available to take care of cattle left in barn over night. Feed and water will be furnished during this time.

4. ALL BUYERS MUST ESTABLISH IDENTIFICATION WITH LIVESTOCK MARKET OPERATOR PRIOR TO SALE.

- 5. Assistance in obtaining transportation will be given if needed.
- 6. Auctioneer will settle all disputed bids.
- 7. Calves will be sold in uniform lots according to breed, grade, sex, and weight and may be purchased by the pen or buyer may take a pen sheet, cut any number over ten, provided not less than ten are left in the pen after cut.
- 8. Any departure from this procedure will be announced from the auction stand and such announcement will take precedence over printed matter herein.

Producer/Cattle Requirements

- All cattle have received at least one dose of Modified Live Vaccine with Pasteurella.
- All cattle have received at least 1 dose of blackleg/clostridial vaccine
- All cattle have been properly castrated, dehorned, and completely healed.
- All calves have sale ear tags and not back tags.
- All cattle must be consigned. Any cattle not consigned for sale may stand in the barn until consigned cattle are weighed and graded or there are no consigned cattle waiting to be graded.
- Consignments for Norwood Area Feeder Cattle Sales are strongly encouraged by one week prior to sale date. Consignments are necessary for effective marketing so cattle buyers can plan cattle placements and trucking arrangements. Call 704-322-9770 to consign cattle.
